The tenderers must possess **Digital Signature Certificate** for submission of tenders through online in the above website. Tenderers shall submit their tender in electronic format on above mentioned website after digitally signed the same. Tenders which are not digitally signed will not be accepted.
2. Tenders must be submitted through online upto 6.00 P.M. (As per Server Clock) on the last date mentioned in column 8. Tenders received through online shall be opened at 03.15 P.M. (As per server clock) on the opening date as per column 9 in the office of the Superintending Engineer/Chennai Circle, Tamil Nadu Police Housing Corporation Limited, No.132, E.V.R. Salai, (Poonamallee High Road), Near G-3 Police Station, Kilpauk, Chennai-10. If the date of opening happens to be a holiday, the tenders will be opened on the next working day at the same time and venue.
3. **“The online payment Gateway has been enabled for TNPHC in TN Tenders Portal (<http://tntenders.gov.in>). The payments for the tenders like EMD etc., will be carried out by the Bidders only through online payment gateway mode”.**
4. **The EMD amount should be the exact amount and no excess or less amount should be transferred through online payment gateway. If excess or short, the tender status will be shown as invalid.**

The contractors those who have carried out such type of similar works are the most preferable.

**II. For Pre-Qualification tender costing more than ₹ 500.00 Lakhs for the above work.**

The tenderers are requested to upload the following documents with duly attested by Notary Public / Gazatted Officer of State or Central Government) in all the Pages.

**Cover-A:**

- a. EMD (Through online payment Gateway mode).
- b. Tender processing fee of Rs.10,000/- + GST @ 18% for Pre-Qualification works to be remitted by the tenderers in the form of Demand Draft in favour of Executive Engineer / Chennai Division – I / TNPHCL and the scanned copy of the same will be uploaded along with tender documents which will not be refunded. Original Demand Draft should be handed over to the tender opening authority during opening of tender. Failure in submission of original Demand Draft, during opening of tender, the tender will be summarily rejected.
- c. Scanned copy of the following credentials.
  - i) **The Applicant shall be any Person, Company, Corporate body, Limited Company, Firm, Organization from India who are legally competent and entitled to enter into contract as per the law of contract prevailing in India. The applicant should produce the evidence for the above.**

(or)

**The Applicant shall be registered with Central Public Works Department / any State Public Works Department under Class I Level (as per revised classification) with monetary limit**

- ii). **The Applicant in the same "NAME" and "STYLE" should have been in the field of Laying of Synthetic Athletic Track at least for the past "FIVE" years. The contractor should have registered office in India**

**AND**

**If a registered single contractor has changed and registered his/ her "Name and Style" to a Company/ Partnership Firm within the period of past Five Years, is also be considered for this criteria, subject to the condition that the registered individual contractor is one of the partner and having experience in Civil Engineering/ Electrical Engineering field / Laying of Synthetic Athletic Track for at least 5 (five) Years**

- iii). **The applicant shall be authorized dealer / manufacturer of Synthetic material. Proof for the same should be enclosed in the Technical Bid. Registration certificate of the company or firm, License copy where Bidder is the manufacturer should be enclosed. In case of an authorized Dealer, dealership certificate issued by the manufacturing company should be enclosed**
- iv) Income tax certificate (2025-26).
- v) Goods and Service Tax (GST) Registration certificate with 3 years GST Annual Returns (i.e. Form GSTR – 9).
- vi) Proof of incorporation certificate issued by Registrar of companies.
- a) In case the tender is made by an individual, the tender documents shall be digitally signed by the individual with his name and address and submit along with a copy of (duly attested by Notary public / Gazatted officer) proper contractor registration certificate.
- b) In case the tender is made by registered firm, it shall be digitally signed by the Managing Partner (or) the person authorized by the firm, with full name of the firm and address. The proof shall be submitted along with the copy of **Registered Partnership Deed** and current renewal for firm registration i.e., Form 'C' obtained from the registrar of firms with proof of renewal. (Copies should be duly attested by Notary Public/ Gazatted officer). **Renewal receipt for Form 'C' certificate of previous year renewal will be considered upto June of current year.**
- c) In case the tender is made by a limited company or a limited corporation, it shall be digitally signed by a duly authorized person holding the power of attorney for signing the tender in which case a certified copy of the power of attorney shall accompany the tender. The Articles of Memorandum of the Company and profile of the company with company incorporation certificate copies with seal (duly attested by Notary Public or a Gazatted Officer) shall be submitted along with his / their tender.
- d) In case a tenderer, tendered in the Name and Style of Proprietorship concern the tenderer should have registered his firm name in the respective registrar office and enclose the copy of Proprietorship Deed (duly attested by the Notary Public / Gazatted Officer) along with the tender. The sole proprietor alone should digitally sign in the tender document.
- vii) Revenue Solvency certificate issued by Tahsildar with up to date Encumbrance certificate should be uploaded. The details of Survey number, area etc., of the property mentioned in the Solvency certificate and Encumbrance certificate should be tallied. Encumbrance certificate should be obtained from the date of solvency certificate issued by the Tahsildar, on or after the date of tender notice of the respective works. EC should be free from Encumbrance. EC obtained from the **Government website** shall be considered for PWD / TNPHC Ltd registered contractors.

**(i). Banker's Certificate :** Bankers certificate shall be issued by a Scheduled Bank on its letter head addressed to the enlisting authority in the format prescribed in Annexure – I (ii). **Net – worth certificate :** The Net – worth certificate shall be in the format prescribed in Annexure – 2 (iii). **Average Annual Turnover certificate :** Average Annual Turnover certificate shall be in the format prescribed in Annexure – 3 (iv). **Indemnity Bond :** Indemnity Bond should be on Non-Judicial Stamp Paper of Rs.500/- with a Notarial Stamp equivalent to the value of Solvency amount as prescribed by the Government in Annexure – 4 (format enclosed in Tender documents)

**viii) In case of tenderer is a Manufacture / dealer of Synthetic materials they should produce Banker solvency for a value of Rs.500.00 lakhs on or after the date of tender notice.**

**ix) The performance Certificate in having Very Good / Good / satisfactorily executed and completed related works. (The completed value including taxes / GST shall be more than 50% of the proposed contract value in a single contract or in two contracts) directly issued by the concerned organization during past five years (i.e. Works executed under sub-contractors shall also be considered, provided that the Performance certificate is issued directly by the organization for whom the work was carried out). The evidence for the same should be produced from an officer not less than the rank of the Executive Engineer or equivalent rank / agreement executing authority of the Government or Government undertakings, responsible person of the Private organization. In case, the contractors who have executed works in TNPHC Ltd., the satisfactory performance certificate in the prescribed format from the authority not lower than the rank of Executive Engineer concerned of TNPHC Ltd., should be furnished. Otherwise the tender will be summarily rejected as per the TT act rule 28 of 2000**

**Credentials of the tenderer(s) for the works executed by him / them in the past 5 years supported by certificate issued by the authority not lower than the rank of Executive Engineer / Agreement Executing Authority / Responsible Person of the Private Organisation. The date of completion of the woks stated in the experience certificate should be within the past 5 years prior to the date of tender.**

**x) . The value of single similar nature of works executed for past five years shall be brought at current price level with the cumulative weightage at a rate of 10% per annum.**

- xi) Scanned copy of the department Pre-qualification tender Schedule containing terms and conditions of Pre-Qualification tender in full shape (i.e) all pages should be uploaded with tenderers credentials.
- xii) The performance certificate in respect of private works should be supported with the annexure - 'P' (available in PQ document) and the performance certificate should cover the works completed during the last five consecutive financial years.
- xiii) The tenderer should furnish the audited Balance sheet and Profit and Loss Account for past five years along with the tender to cover Item No.III & IV of schedule II.
- xiv) The amount received by the tenderer from the end users, incase of experience certificate for Private works has been enclosed by the tenderer, should cover in the certificate issued by IT department indicating the head wise income and tax payable in addition to the Annexure 'P' enclosed in the departmental pre-qualification tender schedule.
- xv) The Annual Turnover should be not less than the **Rs.23.20 crores** in any one year of the preceding the last five year duly certified by the Chartered Accountant.
- xvi) **The applicant should have a minimum issued and called up Share capital plus capital reserves equal to at least is Rs.283.31 lakhs (Rupees Two hundred eighty three lakhs and thirty one thousand only)**
- xvii) **The Applicant should produce “Income Tax SARAL” as produced to Income Tax Department for the proceeding 5 (FIVE) years.**
- xviii) The product offered should be World Athletics (earlier International Association of Athletics Federations (IAAF)) Approved FULL PUR Track and should be minimum 14mm thickness as per World Athletics approval Certificate
- xix) The offered product should be of European, Australian, American. Country of origin will be double checked at the time of issuing of Custom Duty Exemption Certificate (CDEC) Letter for getting Custom Duty Exemption Certificate (CDEC) from Sports Development Authority of Tamil Nadu (SDAT) will be issued by TNPHC Ltd. Incase Custom Duty Exemption Certificate (CDEC) will not be accepted by customs in any circumstances, duty will be borne by the contractor.
- xx) The brand / product offered by the bidder must have been installed in at least three (3) World Athletics (formerly International Association of Athletics Federations (IAAF / World Athletics)) Class – 2 / Class – I Certificate Synthetic Track projects, including sub-base work, by the bidder as the **Prime Contractor / Sub-contractor** in India within the last five years, for any Government Department / Private Organisation **(i.e. Works executed under subcontractors shall also be considered, provided that the Performance certificate is issued directly by the organization for whom the work was carried out)**. (Work experience certificate and the corresponding Class – 2 / Class – 1 Certification must be submitted with the bid) and TDS for Private works. Proof to be enclosed.

- xxi) Affidavit should be furnished in **Rs.200/- Stamp Paper** as per the format (Annexure 'M') (available in PQ document).
- xxii) The bidder should certify that never have been debarred or blacklisted by any Central / State Government / Sports Authority / Municipal agency in Affidavit.
- xxiii) The bidder should upload Micro, Small and Medium Enterprises (MSME) certificate.
- xxiv) **2 Years free maintenance should be done by the contractor for the above work after completion and handing over of the site.**
- xxv) **All the credentials enclosed in the tender document should be duly attested by Notary Public / Gazetted officer.**
- xxvi) Proof for work force, Tools & Plants and Machineries as specified in the document / Affidavit and duly authorised by the Chartered Accountant.

**Cover-B:**

- a. Digitally signed and filled tender coding sheet (i.e. BoQ – in excel format - Booklet –4) in addition to the digitally signed remaining three booklets in pdf format uploaded. (totally 4 Booklets).

**IV. INSTRUCTIONS :**

1. The PQ tender containing the Technical Bid will be evaluated on **PASS (or) FAIL** basis those of tenderers who have passed in the PQ alone stand qualifying for the opening of price bid.
2. The tenderer should be accompanied by two covers i.e. Cover – A – ‘Technical Bid & Cover – B – Financial Bid’.
3. At the time and date notified above for opening, the Technical bid will be opened first. The tenders will be evaluated on the basis of PASS or FAIL method. After evaluation, the price bid of the tenderers of those qualified in the Pre-Qualification will be opened on a later date.
4. No tenderer is permitted to withdraw his/her/their tender at any stage. If any tenderer withdraws his/her/their offer within the tender validity period his / her / their EMD/SD shall be forfeited and his / her / their names (s) will be recommended for blacklisting in future.
5. The performance quality of work, character and integrity of the aspiring tenderers should be satisfactory. Also the contractor should have executed related works within the agreement period or extension of time granted.
6. The Contractor shall furnish the performance certificate of works should contain the details such as period of completion, Extension of time granted if any along with fine imposed if any.
7. **Repetition of the tender document uploaded by the tenderer should be avoided. The lowest tenderer should produce the original document before finalizing the tender for verification of the copy of the documents already uploaded by him / her / their in the on line tender.**

**NOTE :-**

1. The tenderer should be registered with GST.
2. **Price Adjustment Clause as per G.O.Ms.No.101 Public Works (G2) Dept, Dt : 10.06.2009 is applicable for the above work.**
3. The tenderers shall furnish the performance certificate of works should contain the details such as Agreement value, period fixed for completion, actual date of completion, Extension of time granted if any along with fine imposed if any, value of work completed, performance of the contractor.
4. The performance certificate in respect of private works should be supported along with TDS Statement (i.e. Form 16A & Form 26AS).  
Credentials of the tender(s) for the work executed by him/them in the past 5 years supported by certificate. The date of completion of the works stated in the experience certificate should be within the past 5 years prior to the date of tender.
5. The total value of a contract which exceeds Rs.2.50 Lakhs 2% GST Tax at Source will be deducted.
6. The tenderer shall quote the rates and prices (both in figures and words) for all the items of the works described in the Bill of Quantities excluding GST.
7. EMD exemption is not entertained vide G.O Ms.No.270 Finance (Salaries) department dated .19.09.2017.
8. Government of India has notified vide Notification No.20/ 2017 – Central Tax (Rate), dated 22nd August, 2017 and Notification No.24/2017 – Central Tax (Rate) dated 21st September, 2017, the concessional rate of the Goods and Services Tax (GST) at 12% [ CGST at 6% + SGST at 6%] is leviable for any Government Contract, whether Civil or Electrical, irrespective of the Goods and Services Tax (GST) rate applicable on purchase of goods used in the execution of Government Contract. However, with effect from 01.01.2022 CBIC notification number 15/2021 (CTR) dated 18<sup>th</sup> November 2021 by amending principal notification number 11/2017 has removed the Government entity from the above concession rate and made all the works contract services provided to government entity are taxable at 18%. Hence, the GST amount will be calculated at 18% from the sum of total tendered value quoted by the tenderer for construction cost (excluding GST) specified in the BOQ, subject to GST rate applicable from time to time as recommended by the GST Council.
9. All duties, taxes, and other levies except GST, payable by the contractor under the contract, or for any other cause shall be included in the rates, prices and total Bid Price submitted by the Bidder.
10. The Contractor should be required to indicate their GST registration number under the Goods and Services Tax (GST) Act 2017 in the tender form. The Central Goods and Services (CGST) Act 2017, the Integrated Goods and Services (IGST) Act 2017 and the Tamil Nadu Goods and Services (TNGST) Act 2017 have been enacted and enforced from 01.07.2017. Under the new CBIC notification number 15/2021 (CTR) dated 18.11.2021 by amending principal notification number 11/2017 with effect from 01.01.2022 all the works contract services provided by Government entity are taxable at 18%.
